

II. The subject of the inquiry

It is expected that the responder, using his knowledge and experience, best practice and proven tools and methodology, will evaluate the availability of software license for airport slot coordination in accordance with requirements of the IATA World Slot Guidelines (WSG).

- 1. The response to the inquiry should include as follows:
 - 1.1. Descriptive information regarding:

Training of Users (group of up to 10 people, duration: 5 days, at PANSA headquarters in Warsaw)

The scope and cost of Technical Support

Required parameters of links and workstations

Data security

- 1.2. Descriptive and price information including the following elements:
- **1.2.1. Basic Module –** enables basic slot request management for coordinated airports, creating reports and databases adapted to the current coordination parameters for the Krakow-Balice airport with the possibility of expansion to an additional airport / airports
- **1.2.2.** Runway capacity management module -enabling automatic management of runway capacity in accordance with the adopted coordination parameters
- **1.2.3. Module for managing the capacity and flow of passengers -** enabling automatic management of the capacity of the terminal in accordance with the adopted coordination parameters
- 1.2.4. Module for managing parking apron capacity and occupancy
- 1.2.5. Noise reduction constraints module
- 1.2.6. Module for monitoring the use of slots enabling verification of allocated slots usage
- **1.2.7. Module for automatic processing slot requests-** enabling automatic processing of messages regarding the demand and availability of slots
- **1.2.8.** Online coordination module enabling live preview of allocated slots and cooperation with airline operators in the scope of coordinating flight schedules
- 1.2.9. Database backup the ability to create a database backup for the selected period for analytical and backup purposes
- **1.2.10.Analytical and planning module -** enabling preparation of potential scenarios and simulations based on historical data
- 1.2.11. Operational Graphic interface enabling graphical visualization of the operational situation
- 1.2.12.Reporting module enabling automatic creation of reports and statistics according to the users' needs
